**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ELK GROVE
FINDING THE ELK GROVE FLORIN ROAD AT ELK GROVE PARK SIDEWALK INFILL
PROJECT (WAC026) EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY
ACT AND APPROVING THE PROJECT**

WHEREAS, the Elk Grove Florin Road at Elk Grove Park Sidewalk Infill Project (WAC026) (Project) includes construction of approximately 1,100 feet of concrete sidewalk, curb and gutter, drainage improvements, ADA ramps, minor pavement widening, street lights, pedestrian crossings, new path connections within Elk Grove Park to the existing path, utility relocations, and other related improvements, on Elk Grove Florin Road from Carmel Valley Way to Valley Oak Lane; and

WHEREAS, construction activities and improvements will include sidewalk, curb and gutter, ADA ramps, minor pavement widening, drainage improvements, street lighting, flashing and utility relocations to remove a barrier to accessibility by constructing a new section of sidewalk and improving other sections of existing sidewalk; and

WHEREAS, the Project is a project under the California Environmental Quality Act (Section 21000 et seq. of the Public Resources Code, hereinafter referred to as CEQA), which requires that cities consider the environmental consequences of their actions before approving a project; and

WHEREAS, Section 15332 (Class 32: In-Fill Development Projects) of the State CEQA Guidelines (Chapter 3 of Division 6 of Title 14 of the California Code of Regulations) provides an exemption from CEQA for projects which are consistent with applicable general plan designations, policies, and zonings; occur within city limits and consists of no more than five acres; would not result in any significant effects relating to traffic, noise, air quality, or water quality; and which can be adequately served by all required utilities and public services; and

WHEREAS, the Project would fill in gaps within the existing network of pedestrian facilities, providing more accessibility that is both safer and ADA compliant, and as this in-fill development is consistent with the City's general plan designation and general plan polices regarding pedestrian paths and accessibility, occurs within the City limits, is under five acres in size and is substantially surrounded by urban use, and would not result in any significant effects relating to traffic, noise, air quality, water quality, or endangered, rare or threatened species, the Project is exempt under CEQA Categorical Exemption 15332 (Class 32: In-Fill Development Projects); and

WHEREAS, the Project is included in the approved Capital Improvement Program Five Year Plan.




