**WHEREAS**, the Department of Public Works acquired a deed for real property for Lane County, properly executed on the date set after the name of the Grantors, and before the recording information in the Lane County Deed Records, and the Board of County Commissioners of Lane County deeming it proper, as a convenience for property owners in the area and as a benefit to the general public, to accept the following deeds as county road as herein set forth below:

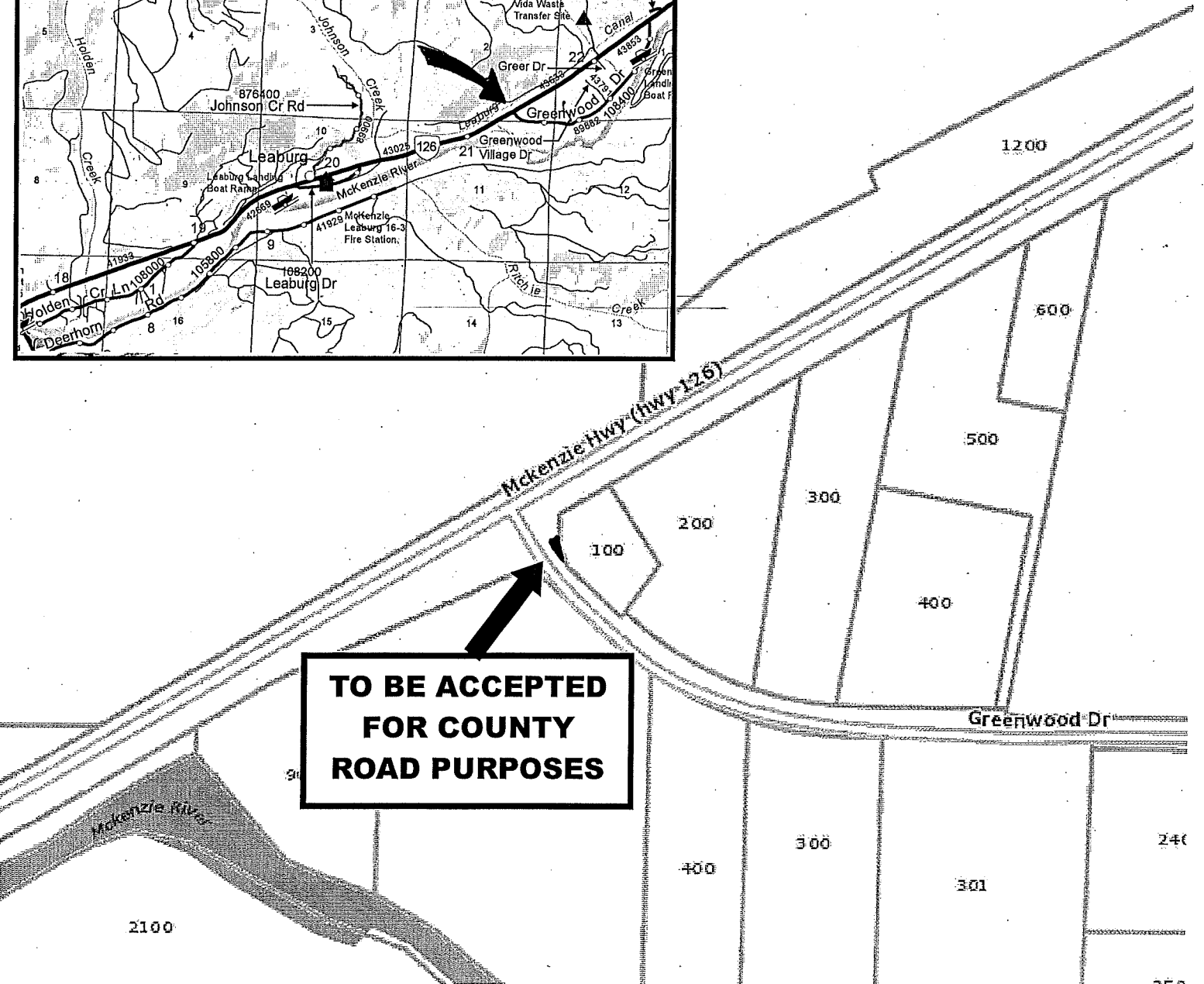
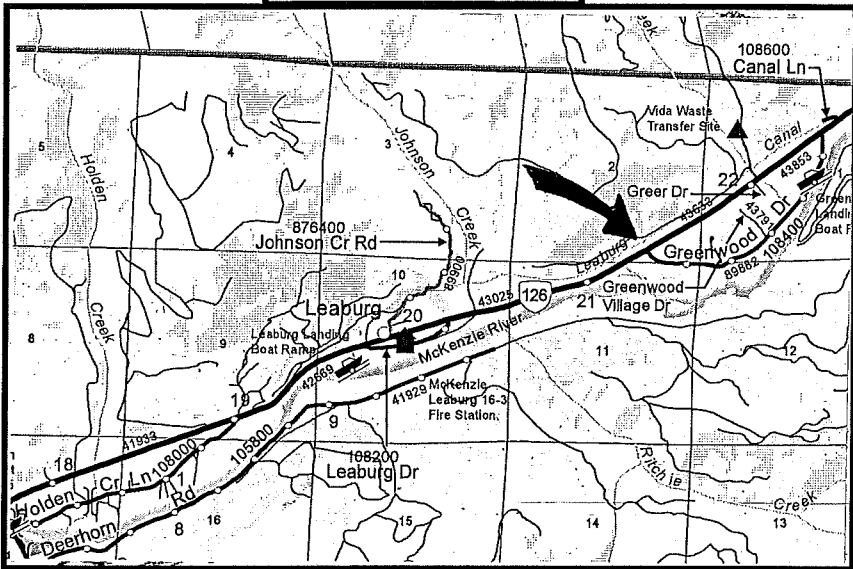
## Intersection Improvement at McKenzie Hwy
