WHEREAS, on March 29, 2013, Dave Brown, Construction Services Manager at Lane County Department of Public Works, under authority of Lane Manual, Chapter 21, opened bids for Un-Coated Oil Rock & Sanding Rock Materials Various Stockpile Sites, Prospective Contract No. 12/13-06; and


WHEREAS, Wildish Building Material dba Wildish Sand & Gravel Co., submitted the low bid of \$72,071.20, and the Director of the Department of Public Works recommends that the bid be accepted;

NOW, THEREFORE, The Board of County Commissioners of Lane County **ORDERS** as follows:

1. That the bid received from Wildish Building Material dba Wildish Sand & Gravel Co., be accepted as recommended;
2. That the afore-mentioned bidder be awarded a contract for Un-Coated Oil Rock & Sanding Rock Materials, Various Stockpile Sites, in the amount of \$72,071.20, in accordance with the bid specifications;
3. That a contract be executed in accordance with this Order and the bid specifications, provided the contractor presents a Performance Bond and a Payment Bond, each for the full amount of the contract, prior to execution;
4. That following receipt of the contractor's Performance Bond and Payment Bond, the County Administrator be authorized to sign the contract.
