IN THE DEPARTMENT OF HEALTH &  
HUMAN SERVICES

**WHEREAS**, the State of Oregon, Eugene Water and Electric Board and Northwest Natural fund Lane County to provide energy assistance services to their low-income customers; and

**WHEREAS**, Lane County provides these services through subcontracts with provider agencies; and

**WHEREAS**, the contracts for energy assistance services are set to expire September 30, 2013; and

**WHEREAS**, Lane County Department of Health & Human Services desires to consolidate energy assistance services into the community service centers; and

**WHEREAS**, the Lane County Department of Health & Human Services will be securing contracts for community service centers with services set to begin October 1, 2014; and

**WHEREAS**, extending current energy assistance contracts through September 30, 2014 will allow staff to engage in competitive selection and execute services contracts for community service centers that include energy assistance services;

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. that the contracts for low-income energy assistance services be extended through September 30, 2014.
2. that the County Administrator be delegated to sign contract amendments as listed in Exhibit A.


