GRANT AWARDS TOTALING \$519,110
FROM THE OREGON CRIMINAL
JUSTICE COMMISSION, ADDING 1.0
FTE IN THE DISTRICT ATTORNEY'S
OFFICE SPECIAL REVENUE FUND AND
APPROPRIATING REVENUE AND
EXPENSE IN THE AMOUNT OF \$389,804
IN PUBLIC SAFETY, SPECIAL REVENUE
FUND AND \$129,306 IN DISTRICT
ATTORNEY'S OFFICE, SPECIAL
REVENUE FUND

WHEREAS, Drug Court is a criminal justice model that has proven to reduce criminal recidivism and costs of health care, food stamps, unemployment, child welfare and other costs to the taxpayer; and

WHEREAS, the Lane County Sheriff's Office worked collaboratively with the Oregon Judicial Department, Emergence, Inc. and Sponsors Inc, to prepare grant proposals to fund expanded treatment and counseling services to participants of the Drug Court and Veteran's Court; and

WHEREAS, Oregon Criminal Justice Commission awarded the Lane County Drug Court \$416,617 and the Lane County Veteran's Court \$102,493 for a total of \$519,110; and

WHEREAS, Board approval is required for any contract that exceeds \$100,000; and

WHEREAS, the Board of Commissioners, per ORS 294.338(2), can authorize expenditure of specific purpose grants in the year of receipt; and

WHEREAS, the need, the purpose, and the amount of the grant are herein described;

NOW THEREFORE, IT IS HEREBY ORDERED, that the Board of Commissioners accepts two awards totaling \$519,110 from the Oregon Criminal Justice Commission and delegates authority to the County Administrator to sign all grant-related documents; and be it further

ORDERED that the Board of Commissioners delegates authority to the County Administrator to sign the following contracts with community agencies to implement grant activities for the period 9/1/2013 through June 30, 2014 (make the date formats match?); and be it further


