IN THE MATTER OF APPOINTING TWO

BE SELECTED BY THE COUNTY CLERK  
TO SIT ON THE BOARD OF PROPERTY  
TAX APPEALS

appoint one pool of non-office holding resident members representing the Board of Commissioners to act as Chair for any Board of Property Tax Appeals, and one pool of non-office holding residents of the county who are not employees of the county or any taxing district within the county as prescribed by ORS chapter 309 ; and

**WHEREAS**, the Board of Commissioners having fully considered this matter, and upon review by Commissioner Sid Leiken, liaison to the Board of Property Tax Appeals; and

**WHEREAS**, appointment of the pools for the Board of Property Tax Appeals is mandated by ORS chapter 309; and

**WHEREAS**, the newly filed pool of appointees shall become effective upon approval of this Board Order;

**NOW, THEREFORE**, the Board of County Commissioners of Lane County **ORDERS** as follows: that the following named individuals be appointed to serve as members of the 2015-2016 Board of Property Tax Appeals for a term pursuant to ORS 309.020; and that this Order shall be entered in the records of the Board of County Commissioners of Lane County.


