ORDER NO: 17-01-10-05

**IN THE MATTER OF GRANTING
AUTHORITY PURSUANT TO ORS 476.280
TO EXTINGUISH UNCONTROLLED FIRES
IN UNINCORPORATED LANE COUNTY**

WHEREAS, the Board of Commissioners directed staff to work on a plan to deal with a variety of emergency situations including uncontrolled fires in unincorporated areas of Lane County that are not covered by existing fire protection districts; and,

WHEREAS, the Board of Commissioners has adopted a Strategic Plan that identifies three priorities for Lane County for 2014-2017: (1), Safe and Healthy County, (2) Vibrant Communities, and (3) Infrastructure; and,

WHEREAS, the Lane County Strategic Plan states that, Priority I, Objective I, is to ensure safety throughout Lane County; and,

WHEREAS, ORS 476.280 authorizes the governing body of any duly organized body to extinguish any uncontrolled fire found to be burning in an unprotected area; and,

WHEREAS, The Board of Commissioners of Lane County has jurisdiction over unincorporated areas of Lane County that are not covered by existing fire protection districts as shown in more detail on Attachment "A", which is by this reference incorporated herein; and

NOW, THEREFORE, the Board of County Commissioners of Lane County **ORDERS** as follows:

1. The fire chief, or representative of the fire chief, of any duly organized municipal or rural fire protection district may extinguish any uncontrolled fire found to be burning in any unprotected and unincorporated area of Lane County if:


a. The governing body of the city or district board of the rural fire district, as the case may be, has authorized the fire chief and the representatives of the fire chief to extinguish uncontrolled fires that are found to be burning in unprotected and unincorporated Lane County situated outside the boundaries of the city or district are causing or may cause undue jeopardy to life or property; and

b. The fire chief or the representative of the fire chief believes that such fire is causing or may cause undue jeopardy to life or property.

2. This Order shall be reviewed annually by the Board. Failure to review this Order does not affect its continuing validity.

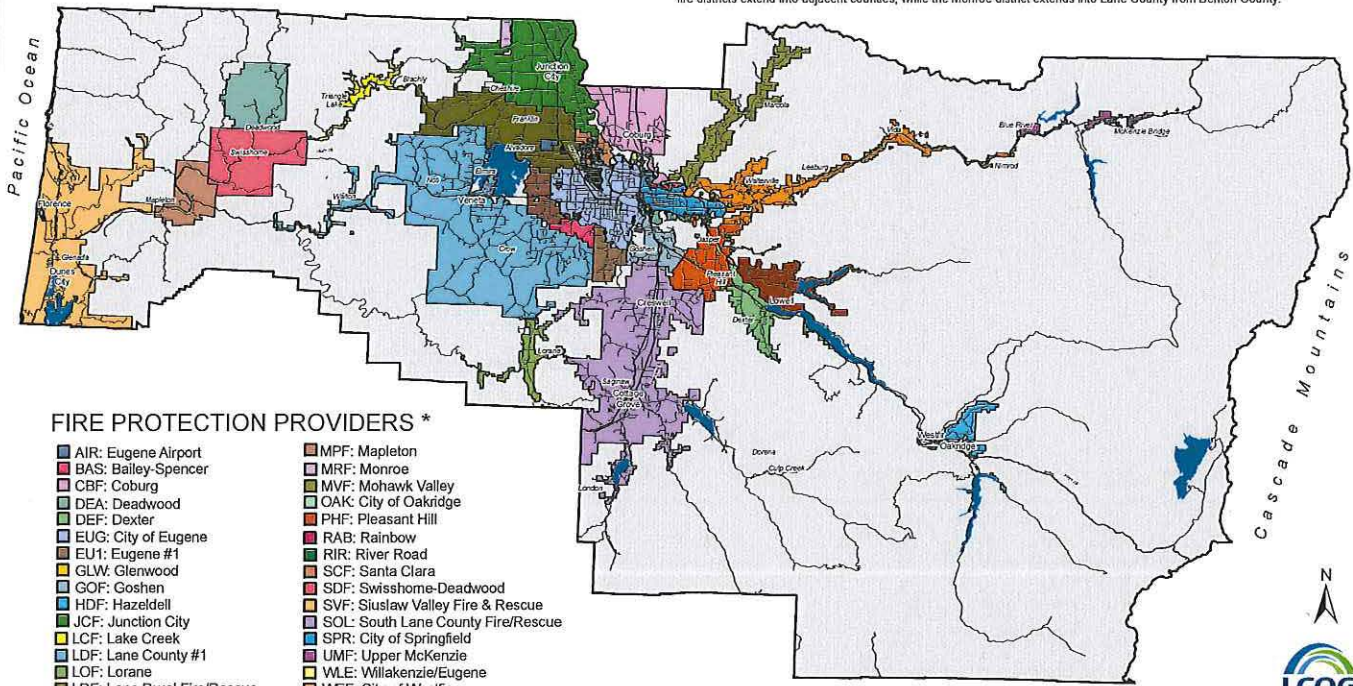

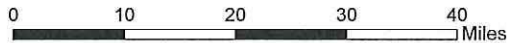
Fire Districts* in Lane County

* Various types of fire protection providers are shown on the map. Most are either RFPDs or Water Districts. Deadwood (DEA) is a volunteer organization and the service area may not be accurately depicted. The cities of Eugene and Springfield jointly provide fire protection service inside their combined city limits. Eugene also provides fire protection for the Eugene Airport (AIR). The cities of Oakridge and Westfir provide fire protection through contract, as do several districts in and around the Eugene-Springfield area (BAS, ZUM, RIR, EU1, GLW, WLS, and RAB). Small private contract areas are not shown on the map. Some Lane County fire districts extend into adjacent counties, while the Monroe district extends into Lane County from Benton County.
